SUMMARY OF RESEARCH INTERESTS.

The main research interests are related to the use of marine organisms as bioindicators of chemical pollution and environmental disturbance, with particular emphasis to the influence of biological and environmental factors on the bioaccumulation of traditional and emerging compounds.

Biological effects induced by traditional and emerging pollutants are investigated at the molecular, cellular and biochemical levels through a wide panel of biomarkers reflecting the main detoxification and metabolism pathways or the occurrence of toxic alterations. These studies are carried out on fish and invertebrates and the main investigated biological responses include: destabilization of lysosomal system, modulation of cytochrome P-450 system, metallothioneins, acetylcholinesterases, peroxisomal proliferation, variations of antioxidant defenses and susceptibility to oxidative stress, assessment of total antioxidant capacity, peroxidative processes, genotoxicity and oxidative DNA damage, endocrine effects and vitellogenin gene induction. Modulation of these systems is investigated to highlight links, cross-talks and interactions between pre-transcriptional level, gene expression, translation and functional-catalytic levels.

These studies are applied to management and monitoring of coastal areas, potential transfer of pollutants and risk to human health, sustainable aquaculture and animal welfare, dredging and disposal activities, impact assessment of off-shore gas and oil production, environmental management of highly polluted areas, remediation of industrial areas, biological effects of global changes in temperate and polar latitudes, molecular mechanisms of adaptation to extreme environmental conditions.

The main scientific lines include:

- Intracellular generation of reactive oxygen species, antioxidant defences and oxidative stress in biological models.
- Mechanisms of toxicity and detoxification of chemicals at molecular, biochemical and cellular levels, particularly for lysosomal system, cytochrome P450, metallothioneins, acetylcholinesterase, peroxisomal proliferation, antioxidant system, lipid peroxidation, structural integrity and oxidative damages to DNA, endocrine effects and gene expression.
- Relationships between pre-transcriptional control, gene expression, post-transcriptional modification, catalytic activities and functional efficiency of cellular defences.
- Development of new cellular biomarkers, with emphasis on total antioxidant capacity, DNA oxidation, endocrine effects.
- Cellular mechanisms involved in adaptation or vulnerability to extreme conditions and symbioses.
- Cellular and tissue accumulation of trace metals, polycyclic aromatic hydrocarbons, halogenated compounds.
- Cellular effects of microplastics in marine organisms.
- Pharmaceuticals in the marine environment, bioaccumulation and molecular to functional effects in marine species.
- Chemical speciation and cellular metabolism of arsenic.
- Biomagnification, trophic transfer of pollutants and possible sanitary risk to humans.
- Use of molecular and cellular biomarkers in several scenarios of environmental impact assessment, such as management of dredged or polluted sediments, remediation, off-shore exploitation, petrol-chemical installations, coastal lagoons, aquaculture.
- Development and validation of risk assessment models.
- Use of bioindicators and cellular biomarkers for soil and air pollution, and for ecotoxicological effects of electromagnetic fields.
- Antioxidant potential of natural products, pharmaceuticals and biological fluids.
